The PowerShares 1-5 Year Laddered Investment Grade Corporate Bond Index ETF (PSB) seeks to replicate, before fees and expenses, the performance of the DEX Investment Grade 1-5 Year Laddered Corporate Bond Index. The index is comprised of Canadian investment-grade corporate bonds divided into five buckets with staggered maturity levels from one to five years.
