- The market-cap-weighted MSCI EAFE 100% Hedged to CAD Index represents primarily large-capitalization companies in developed equity markets throughout Europe and the Pacific region.
- Includes approximately 950 common stocks of companies in approximately 22 countries in Europe, Australia, Asia and the Far East.
